Advanced Title IX Investigator Workshop

In light of the heightened awareness, shifting guidance and a rise in investigations, education institutions must train their Title IX coordinators and investigators to effectively investigate and resolve alleged incidents of sex and gender discrimination, sexual harassment and interpersonal violence. You and your institution have laid the groundwork with policies, programs and basic training on compliance with Title IX, the Violence Against Women Act (VAWA) and the Clery Act. Now dig deeper into the practical skills needed to conduct effective sexual misconduct investigations. Training includes traditional presentations, videos and interactive sessions with up-to-date information on responding to sexual misconduct in a manner that ensures fairness, accuracy and compliance. Training topics include Techniques: structure, process, questioning and nuance; Reluctant complainants, difficult witnesses and challenging support persons; Collection and organization of evidence; Credibility determinations and weighing of evidence; and Creating accurate and meaningful investigation reports.
